

Matica Fintec: INFORMATION ON THE PURCHASE OF OWN SHARES

Milan, 13 June 2022

Matica Fintec S.p.A. (or "Matica"), an Innovative SME listed on the Euronext Growth Milan market, organized and managed by Borsa Italiana S.p.A., active in the design, production and marketing of Digital ID and payment solutions, announces that, as part of the programme for the purchase and disposal of treasury shares, approved by the Ordinary Shareholders' Meeting on 14 April 2021 (for a period of 18 months from the date of approval by the Shareholders' Meeting) and initiated by the Board of Directors on 03 May 2021, it purchased, in the period between 06 June 2022 and 10 June 2022, a total of 28,800 shares at a weighted average unit price of approximately EUR 2.63 per share, for a total value of EUR 75,816,00. The purchases of treasury shares were made through Intermonte SIM S.p.A., as the intermediary appointed to carry out the transaction, in compliance with applicable laws and regulations and according to the terms and conditions contained in the authorisation to purchase and dispose of treasury shares granted by the Company's Ordinary Shareholders' Meeting.
